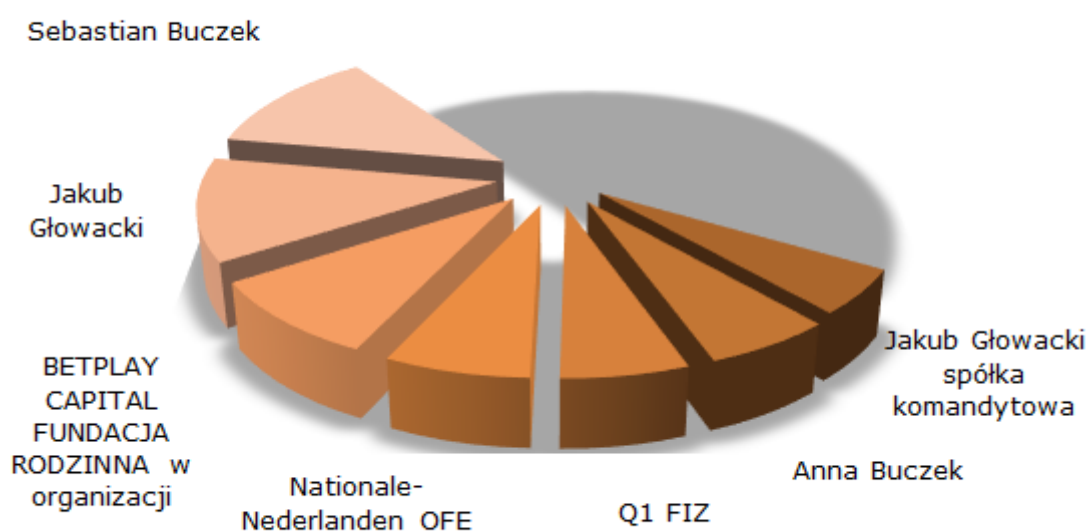


Shareholder structure
