Quercus TFI S.A. hereby announces that the value of assets under management of the company as of 31 October 2014 was PLN 3,103.3m.

The above mentioned value of assets under management included:

- 2,657.3m assets of nine sub-funds of QUERCUS Parasolowy SFIO,
- 134.4m assets of QUERCUS Absolute Return FIZ (net assets value of the fund according to the valuation on 30 September 2014; that is the last valuation available),
- 227.2m assets of QUERCUS Absolutnego Zwrotu FIZ (net assets value of the fund according to the valuation on 30 September 2014; that is the last valuation available),
- 29.2m assets of Acer Aggressive FIZ (net assets value of the fund according to the valuation on 30 September 2014; that is the last valuation available),
- 55.2m assets of financial instruments portfolios managed by Quercus TFI S.A. within the range of the asset management service (excluding assets invested in sub-funds / funds managed by Quercus TFI S.A.).

Moreover, Quercus TFI S.A. manages the dedicated fund Q1 FIZ with asset value of 71.7m. (net assets value of the fund according to the valuation on 30 September 2014; that is the last valuation available).
