**Content:**

Quercus TFI S.A. announces that today it concluded with the Bank Polska Kasa Opieki S.A. with its seat in Warsaw a fixed-term deposit agreement for the amount of 14.000.000.00 PLN. The completion date was set on 26 June 2013. The interest rate of the above-mentioned deposit does not differ from market conditions.

Agreement was considered significant because its value exceeds 10% of the Issuer's equity.
