- 28.2m assets of Acer Aggressive FIZ (taking into account the redemption of the investment certificates as of 28 February 2014),

- 59.0m assets of financial instruments portfolios managed by Quercus TFI S.A. within the range of the asset management service (excluding assets invested in sub-funds / funds managed by Quercus TFI S.A.).

Moreover, Quercus TFI S.A. manages the dedicated fund Q1 FIZ with asset value of 63m PLN (net assets value of the fund according to the valuation dated 20 January 2014; that is the last valuation available).
