The above mentioned value of assets under management included:

- 3,747.1m assets of nine sub-funds of QUERCUS Parasolowy SFIO,
- 171.1m assets of QUERCUS Absolute Return FIZ,
- 255.3m assets of QUERCUS Absolutnego Zwrotu FIZ,
- 25.6m assets of Acer Aggressive FIZ,
- 48.6m assets of financial instruments portfolios managed by Quercus TFI S.A. within the range of the asset management service (excluding assets invested in sub-funds / funds managed by Quercus TFI S.A.).

Moreover, Quercus TFI S.A. manages the dedicated fund Q1 FIZ with asset value of 64.7m PLN
