Quercus TFI S.A. announces that today it concluded with the Bank Polska Kasa Opieki S.A. with its seat in Warszawa a fixed-term deposit agreement for the amount of PLN 10,000,000.00. The completion date was set as of 17 June 2014. The interest rate of the above-mentioned deposit does not differ from market conditions.

Agreement was considered significant because its value exceeds 10% of the Issuer's equity.
